As per the guideline of Hon. Supreme Court, New Delhi, Government of Maharashtra and Savitribai Phule Pune University, in our college, the committee against sexual harassment of women i.e. Internal Complaint cell is in force since 2002-03.

Even being a co-education college, we have not yet received such complaints so far. The newly admitted students are awared about different practices conducted for students safety in the college campus by ICC & other committee for making the student friendly environment. Monitoring through CCTV cameras, campus supervision are notable efforts. As a preventive measure, on 21st August, 2017, under the guidance of Prin. Dr. Bal Kamble, we have organized a legal awareness workshop under the able guidance of **Justice Padmakar Kestikar**, the secretary, Zilha Vidhi Seva Pradhikaran, Ahmednagar District Court on "Different Laws for Women Safety at Working Place in Society and at Home". Informative session on "Laws against Sexual Violence of Women" was engaged by **Justice Sonal Gupta** in which she made aware the students about the sexual assort; eve teasing cybercrime etc. Total of 105 students of entry level have participated in this workshop. Through such awareness Programmes and periodical counseling of the students, the committee members are trying to keep the students aware and safe from such harassments in & outside the campus.

Committee against Sexual Harassment of Women (ICC) Annual Report 2020-21

In compliance with the instructions of National Commission for women and guidelines issued in implementation of the directives of Hon'ble Supreme Court Judgement dated 13th August, 1997 in the case of Visakha and others vs. State of Rajasthan and Others on the subject of sexual harassment of women in the workplace, our college has duly constituted an Internal Complaint Committee for considering complaints of sexual harassment of women and students working in the Dada Patil Mahavidalaya ,Karjat,Ahmednagar.

Our college gives Co-eduction hence this committee plays a key role in giving moral support and provides Guidence. This Committee is active and in force. This Committee has been re-constituted every year as per the requirement and replacement of members for considering complaints of sexual harassment of women employees.

The Committee organized and participated in variour activities at Social and Institutional level to guide the faculty and Students. The ICC Committee had organized an online lecture regarding the awarness and instructions of how and where the members and committee works. The female faculty from Arts Commerce and Science streams guided their respective students and made them aware about the sexual assort; teasing etc. and the related procedures for its redrassal.

A Complaint Box has been installed in the Girls Common Room for the students to submit their complaints and reach us without hesitation. The Instructions regarding the laws related with Sexual harassment and its concequences has been written near the complaint box which is also displayed in the ladies room. Through such awareness programmes and personal counseling the committee is trying to keep the students aware and safe from such harassments. Our Committee members had attendamed a meeting regarding their involvement in the establishment of Bharosa Cell in Karjat. A grand Opening of the Bharosa cell was inagurated by DYSP Mr Manoj Patil, In presence of



Pricipal Dr Bal Kamble Sir and members of the ICC Committee along with local members.

We explained the evolution & salient features of the ICC committee of the college, different Act related with women harrasment, need of ICC in Educational Institutes etc. The committee works for achiving the Objectives, Terminologies, Prevention, Prohibition, Redressal Penalties and Legal Charges if any. The committee tries to upgrade self-esteem and self-confidence of women and give an insights with respect to Enforcement of constitutional and legal provisions, safeguarding rights of woman & safe environment that is free of sexual harassment.

Covid -19 Pandamic has thrown a fall over the students presence in College. Hence we are forced to organise online awarness sessions perticularly for the newely admitted students,. In our college, as per the guideline of Hon. Supreme Court, New Delhi and Savitribai Phule Pune University, the committee against sexual harassment of women i.e., Internal Complaint cell is in force since 2002-03.

We have coeducation in our college. As a preventive measure, on 12th December, 2021, we have organized an **induction & awareness session which was engaged by Prin. Dr. Bal Kamble.**In his speech, he has awared the newly admitted students about the college discipline, different committees in the college functioning for girl's safety, Prevention of sexual assort; teasing etc. 158 students have attended this programme. Karjat police station, Karjat, has given very informative knowledge about the precautions to be taken to avoid multimedia frauds, sexual harassment, phone data protection etc. 320 students have attended this Programme.

By this way, we are taking continuous efforts to keep our college campus safe for the girl students.
